We may collect non-public personal information about you from the following sources:</li> <li>Information we receive from you in order to perform financial planning, investment advisory, accounting and tax services.</li> <li>Information we receive from you on applications, questionnaires or other forms.</li> <li>Information about your transactions with us or others.</li> <li>Information received from a financial institution.</li> </ul>
How?	All financial companies need to share customers' personal information to run their everyday business. CWA does not disclose any non-public personal information about our existing or former clients to any non-affiliated third parties known to us, except as permitted by law or as described in this privacy policy. For affiliated third parties, CWA limits certain non-public information related to our clients that can be shared.

Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only:</li> <li>sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for non-affiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>
